**RESOLUTION NO. res08142024-1**

**RESOLUTION AUTHORIZING THE EXTENSION OF LOCAL LAW 1 OF 2023**

**WHEREAS**, the Town Board for the Town of Rodman previously adopted Local Law 1 of 2023, a local law imposing a twelve- month moratorium on applications for solar facilities and battery energy storage system within the Town of Rodman; and

**WHEREAS**, the local law was filed with the NYS Department of State on November 13, 2023, thereby making it effective on that date pursuant to §9 of the local law; and

**WHEREAS**, the local law would otherwise expire on September 14, 2024 unless otherwise extended; and

**WHEREAS**, pursuant to §5 of Local Law, the twelve-month moratorium is subject to renewal for cumulative period of up to additional twelve-months, if necessary, by resolution(s) of the Town Board: and

**WHEREAS**, the Town of Rodman Comprehensive Plan Board has been working diligently on developing a Comprehensive Plan which will include article regulation solar and energy systems in the Town of Rodman, but the work of the Comprehensive Board has not completed and additional time is necessary for that purpose; and

**WHEREAS**, the Town of Rodman finds it necessary and compelling and in the best interest of the residents of the Town of Rodman to renew and extend the moratorium for additional period of twelve-months from the date of the original term of Local Law 1 of 2023,

**NOW, THEREFORE BE IT;**

**RESOLVED**, that the Town Board for the Town of Rodman hereby extend Local Law 1 of 2023, a local law posing a twelve-month moratorium on applications, on solar facilities and battery energy storage systems within the Town of Rodman, for an additional period up to twelve-months,

**RESOLVED**, that the entirety of Local Law 1 of 2023 shall remain in full force and effect through September 14, 2025, or until the adoption of new local law or regulations that regulate solar power and energy systems in the Town of Rodman, whichever shall occur first.

The Resolution having been put to a vote of the Town of Rodman Board Members present and constituting a quorum was adopted in accordance with the following roll call vote;
